In 2018, Holmen conducted a root and branch materiality analysis to establish our role in a sustainable future. The work included both internal and external stakeholders, with the results of the analysis providing the basis for the development of Holmen's Group-wide sustainability work, and thus, Holmen sustainability reporting.

During 2019, no new materiality analysis was performed, since the materiality analysis performed during 2018 is still relevant.
